

## FACTS WHAT DOES RBC ROCHDALE DO WITH YOUR PERSONAL INFORMATION?

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>▪ Social Security number and income</li> <li>▪ Account balances and credit history</li> <li>▪ Assets and account transactions</li> </ul>	
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons RBC Rochdale chooses to share; and whether you can limit this sharing.

<b>Who is providing this notice?</b>	RBC Rochdale, LLC and CNR Securities LLC (“RBC Rochdale”)
What we do	
<b>How does RBC Rochdale protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, secured files and secured buildings.
<b>How does RBC Rochdale collect my personal information?</b>	We collect your personal information, for example, when you: <ul style="list-style-type: none"> <li>▪ Open an account or seek financial or tax advice.</li> <li>▪ Enter into an investment advisory contract.</li> <li>▪ Seek advice about your investments or direct us to buy securities.</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. We only collect the information necessary to provide you with the services you’ve requested.
<b>Why can’t I limit all sharing?</b>	Federal law gives you the right to limit only: <ul style="list-style-type: none"> <li>▪ Sharing for affiliates’ everyday business purposes - information about your creditworthiness.</li> <li>▪ Affiliates from using your information to market to you.</li> <li>▪ Sharing for nonaffiliates to market to you.</li> </ul> State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account - unless you tell us otherwise.
Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include: <ul style="list-style-type: none"> <li>▪ <i>City National Bank</i></li> <li>▪ <i>CNR Securities LLC</i></li> <li>▪ <i>Datafaction, Inc. d/b/a AgilLink and Exactuals, LLC</i></li> <li>▪ <i>First American Commercial Bankcorp, Inc.</i></li> <li>▪ <i>Companies with the Royal Bank of Canada (“RBC”) or RBC names such as Royal Bank of Canada, RBC Securities, Inc., RBC Trust Company, Ltd., RBC Wealth Management, RBC Capital Markets, LLC, and RBC Bank (Georgia), N.A.</i></li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ <i>RBC Rochdale does not share with nonaffiliates so they can market to you.</i></li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ <i>RBC Rochdale does not jointly market.</i></li> </ul>
Other important information	
<b>California:</b> Under California law, we will not share information we collect about you with companies outside of City National Bank, unless the law allows. For example, we may share information with your consent, to service your accounts, or to provide rewards or benefits you are entitled to. We will limit sharing among our companies to the extent required by California law. For more information, visit <a href="http://cnb.com/CCPA">cnb.com/CCPA</a> .	
<b>Nevada:</b> If you are a Nevada resident, Nevada law allows us to place calls for marketing purposes to our existing clients. If you do not want to receive marketing calls from City National Rochdale, you may be placed on our “Do Not Call” list by writing to City National Rochdale, 400 Park Avenue, New York, NY 10022 or calling (800) 245-9888. Nevada residents may obtain more information by writing to the Bureau of Consumer Protection; Office of the Nevada Attorney General, 555 E. <b>Vermont:</b> We automatically treat customers with a Vermont mailing address as having limited sharing with our affiliates.	
<b>Trust accounts</b> for which City National Bank is the trustee are protected under special rules of confidentiality. Trust account information is not shared for marketing purposes without specific consent.
